Thank you for choosing to have Live Caricatures at your special event. Caricatures make a wonderful addition to your event as adults and children are thoroughly entertained. Please read the following terms and conditions before completing the Entertainment Agreement form.

#### TERMS AND CONDITIONS

This contract is to confirm your booking has already been agreed upon between the client and the performer.

- Changes to the performance times, start times, or venue must be notified to the performer as soon as possible in writing and agreed upon by both parties. Increases in performance times will incur additional fees to be agreed upon at the performer's discretion and paid as decided between both parties.
- The client's personal details, addresses, and contact numbers will not be forwarded to any third parties without their written permission.
- The performer's personal details, addresses, and contact numbers will only be forwarded to third parties for promotional purposes only.
- The performer will conduct themselves in a responsible and courteous manner. The client reserves the right to dismiss the performer in the event of unreasonable conduct.
- In the event of injury, loss, damage or other matters that arise, both the client and the performer will take responsibility for their own liabilities.
- In the event of the performer being unable to attend, he/she will notify the client as soon as possible and will offer a full refund of the deposit paid.
- In the event of the client having to cancel their proceedings, or being unwilling to have the performer appear as requested, the client will be liable to pay a percentage of the full charges as follows:

(A) Cancellation within 7 days of the event-100% agreed on fees

(B) Cancellation within 8-28 days of event-50% agreed on fees

The deposit already paid by the client is non-refundable, regardless of when the client cancels their event.

The balance of the agreed fee (charges minus \$50 deposit already paid) will be paid to the performer either on the day of the event or on receipt of an invoice from the performer. This is to be agreed upon prior to the event.

Invoices are to be paid in full by the client within 28 days of the date on the invoice.

Unpaid charges or invoices will be pursued; after a fair and reasonable time, if invoices are still not paid. Legal action may be taken.

Standard bank charges and possible interest will be charged for checks or other such money orders that are not honored by the client's bank/building society/money institution. Rates will be charged at the relevant rates applicable at this time.

The rate for live Digital Caricature Events **is \$150 per hour. 3-hour minimum. \$50 for each**

I come with 3 tables with pre-drawing backgrounds that I have created. Also, Plastic sleeves protect the artwork.

The rate for Traditional live Caricature Events **is \$125 per hour. 2-hour minimum. \$50 for each additional hour. 10 to 15 faces per hour in color. 10 to 12 faces B/W this includes pre-drawn backgrounds.**

**The number of people per hour are approximate and cannot be guaranteed.**

I come with Prisma Color Art Sticks, Markers, Pastels, Color pencils, Sketch paper of all sizes, Donkey Easel, or regular standard Easel, Table/Chairs, Lights, and Pre Drawn Backgrounds for guests to have their faces drawn on. Plastic Sleeves to protect the artwork.
